Re: "Extreme Midget Wrestling" at the City of Chandler's Rockin' Taco Street Fest to be held on 09/16/17

Dear Mr. White:

This letter is in reference to a Facebook advertisement for the "Rockin' Taco Street Fest" being held in the City of Chandler (see attached). As Officers of the Little People of America organization at Local, District, and National levels, we condemn the use of the "M word" as it is denigrating, dehumanizing and humiliating to Little People everywhere. What is particularly troubling is that this word is being associated with the City of Chandler's name - a covered Title II entity under the Americans with Disabilities Act.

Little People of America, Inc. (LPA) is dedicated to improving the quality of life for people with dwarfism, while celebrating with great pride Little People's contribution to social diversity. LPA strives to bring solutions & global awareness to the prominent issues affecting individuals of short stature and their families. We are committed to stop the use of the "M word" wherever possible, and to raise awareness to prevent events that objectify, humiliate and denigrate Little People.

The Local Chapters of LPA spanning the entire state of Arizona - the Phoenix LPA Valley of the Sun Chapter, and the Tucson LPA Roadrunners Chapter - condemn the use of the "M word" and the wrestling events that occur in Arizona. Dwarf wrestling is a disgusting spectacle that subjects people with dwarfism to ridicule, physical harm and abuse. While dwarf wrestling is an extreme risk to the individuals participating, it also objectifies and denigrates the entire dwarf community. Dwarf wrestling treats people of short stature as showcase freaks and encourages the general attitude that people with dwarfism are objects to be treated with no respect. Such activities and similar ones like dwarf tossing affect Little People not connected with these events. In 2012, a stranger tossed a Little Person after seeing such an event, and it resulted in irreparable physical and emotional damage to the short-statured individual.

Dwarf wrestling and similar events should never occur in any location in the United States, or around the world. No Little Person, or their friends, family and peers should ever be subjected to the barbarity and denigration of a dwarf wrestling event; and no Little Person should ever again be put at risk because of dwarf wrestling and similar events such as dwarf tossing.

The City of Chandler's ADA website's <u>Policy of Non-Discrimination</u> clearly states: "The City of Chandler does not discriminate on the basis of disability in the admission or access to, or treatment or employment in, its programs or activities." Little People work tirelessly to rise above negative stereotypes and prove that they are equals in society. We are doctors, lawyers, engineers, teachers, etc., and should be treated with the utmost respect - just as everyone else - no more, no less.

We are demanding that the City of Chandler cancel the wrestling event or in the very least delete the word Midget from all advertising. This wrestling event and the advertising associated with the City of Chandler is simply abhorrent. If you need to contact me - my number is 480-331-7247.
